The :60 second music montage will have snippets of 30 songs and the first listener to go to our station website and enter on the contest page, the correct name of the artist and song titles in the correct order will win the contest. The Contest will run from June 13 thru July 1, 2016 Mondays through Fridays, or can end sooner depending on when the correct answer is sent in.
