

Q98.5 Great 98.5 Days of Summer and Gilley's Heating & Air Ram Truck Giveaway Official Contest Rules

A complete copy of these rules can be obtained at the offices of radio station WXXQ-FM ("Station"), owned and operated by Townsquare Media, LLC or one of its subsidiary companies, 3901 Brendenwood Road, Rockford, IL 61107, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the Q98.5 Great 98.5 Days of Summer and Gilley's Heating & Air Dodge Ram Giveaway (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. No purchase is necessary. Void where prohibited. All federal, state, and local regulations apply.
2. Only legal U.S. residents age 21 or older with a valid Social Security number and driver's license at the time of entry are eligible to participate in Station contests. Employees, officers, directors, agents, representatives, or affiliates of the Station, Townsquare Media, LLC its subsidiaries and affiliates, participating sponsors as listed on *Appendix A* to the Official Rules (the "Giveaway Entities"), other radio stations, television stations and print advertising companies serving the metro area, and their immediate family members and household members are not eligible to participate. The term "immediate family members" includes spouses, parents, siblings, grandparents, children, grandchildren and cohabiting significant others.
3. An individual may win an on-going contest only once per six-month period unless otherwise specifically stated. An individual may win other seasonal or one-time contests only once for the duration of the contest. The Station reserves the right to limit the number of times an individual may enter a contest or drawing.
4. The Contest will begin on May 31, 2014 and will run through September 6, 2014 (the "Registration Period"). The Contest prizes will be awarded at the grand prize event on September 13, 2014, as further described in Section 7 (the "Grand Prize Event"). The registration period to qualify to participate in the Contest will begin on May 31, 2014 and run through September 6, 2014.
5. There are two (2) ways to qualify to participate in the Contest:

(i) *Attend a Remote Broadcast or truck registration stop:* Attend a remote broadcast conducted by the Station or Truck Registration Stop conducted by Gilley's Heating and Air during the Registration Period and complete an online entry form. Remote broadcasts will be announced by the Station and publicized on the Station's website. One (1) entry per person, per household, per remote broadcast or truck registration stop. All entries must be received by the deadline stated at the remote broadcast or truck registration stop.

(ii) *Visit a Participating Sponsor:* Visit a participating sponsor's location (see attached *Appendix A* for participating sponsors) and submit a completed registration form online including entry code. One entry per person, per household. All entries must be received by midnight on September 6, 2014. Late, incomplete or illegible entries will be disregarded. Throughout the contest, the Station will randomly select approximately 15,000 entries to qualify to participate in the Contest.

Maximum number of Contest Qualifiers is 15,500.

6. ***Grand Prize Event Tickets:*** All qualifiers will be notified by the Station via email, on or before September 10, 2014. If a participant cannot be contacted or does not respond to the Station's communications in a timely manner, as determined by the Station in its sole discretion, they will be disqualified from further participation in the Contest and the Station reserves the right to select alternate qualifiers. The Station is not responsible for incorrect or incomplete notice delivery. ***TO PARTICIPATE IN THE GRAND PRIZE EVENT, ALL QUALIFIERS***

MUST PRINT OUT A GRAND PRIZE EVENT TICKET BY 5:00PM ON SEPTEMBER 10, 2014. Failure to obtain a Grand Prize Event Ticket will result in disqualification from further participation in the Contest.

7. Grand Prize Event: All eligible qualifiers must attend the Grand Prize Event at the Rockford Speedway (Route 173 and Forest Hills Road) on September 13, 2014. Qualifiers will register with Station representatives between 8:30am and 11:00am by providing their Grand Prize Event Ticket. Qualifiers who do not timely register at the event will be disqualified. Starting at 11:30am, the Station will announce a prize and then conduct a random drawing of all eligible qualifiers for that prize. This process will continue until the Station has awarded all available prizes (approximately 250). Qualifiers must be present to win. One (1) prize per qualifier.

8. Prizes. A minimum of \$98,000 in prizes will be awarded in the Contest. Available prizes are identified on **Appendix B** to the Official Rules. Prizes range in value from \$20 to \$31,610. All taxes (including without limitation federal, state and local taxes) on or connected with each prize and the reporting consequences thereof, and any other costs, fees and expenses not explicitly stated herein are the sole responsibility of the winner. All prizes are awarded "as is." Prizes are nontransferable and cannot be exchanged. No substitute prize will be awarded to a winner who declines to accept a prize. The Station shall not be responsible for the failure of participating sponsors to deliver the prizes or any part thereof as described herein.

9. Odds of qualifying depend on a number of factors including the number of eligible entries received and listeners participating at any given time. Odds of winning are determined by number of eligible entries received and number of prizes awarded.

10. All State, Local, Federal and or other taxes, duties, tariffs, title fees, licensing fees, or other fees for prizes awarded become the sole responsibility of the winner. All those who win a prize or prizes valued \$600 or more in any given year will be issued an IRS Form 1099 to report their winnings.

11. All prizes must be claimed in person at the Grand Prize Event on September 13, 2014. After such time, ownership of said prize reverts back to the Station to be disposed of at its sole and absolute discretion. The winner then loses all claims and rights to said prize. Proper identification must be presented by any winner to claim prize. As a condition to receiving any prize, each potential winner must complete and sign a Winner's Affidavit and Release, releasing the Station and participating sponsors from all liability in connection with winner's participation in the contest and acceptance, use, or non-use of the contest prize.

12. All entrants and winners agree that the Giveaway Entities shall have no liability for any injury, misfortune, or damage to either persons or property incurred by entering, participating in, attending, winning, or losing any contest and/or by the acceptance, use, or non-use of any prize received in connection with this contest.

13. All entry blanks, forms, devices, and materials gathered during the course of entry, as well as all information contained on or within, shall become the sole property of the Station to be used, disposed of or destroyed in its sole discretion. The Station and participating sponsors are not responsible for any incorrect or inaccurate information entered by website users, and assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to the Station's website.

14. All entrants and winners agree to give the Station and its parent entities, licensees, affiliates, successors, and assigns the irrevocable and unrestricted right to use, re-use, broadcast, or publish their name, city of residence, photo, video tape, film or any other likeness, including portraits and pictures, in whole or in part, as part of a composite, retouched or distorted in character or form, and winner's voice, recorded or live, for any reason the Station deems necessary without

compensation, unless prohibited by law. All winners release, discharge, and agree to hold the Station harmless from any and all claims they may have against the Station in connection with the taking, production, or the use of winners' name, city of residence, any photo, video tape, film or any other likeness, including portraits and pictures, in whole or in part, as part of a composite, retouched, or distorted in character or form and without restrictions as to any changes, transformations or alterations, and including winners' voices, recorded or live. All winners further acknowledge that the Station owns or will own exclusively any photographs of such winners used for such purposes, including the copyrights in them, regardless of the form in which they have been or may be produced and used, and all winners assign all such ownership rights to the Station.

15. By participating in the Contest, each participant agrees to receive email communications from the Station regarding Station events and contests. Any participant that opts-out of these mailings may also be removed from the Contest at Station's sole and absolute discretion. By participating in the Contest, where allowed by law, participants agree that the Station may disclose personal information obtained from participants in the Contest to third parties, including but not limited to the contest sponsors and use such information for marketing and other purposes.

16. By participating in the Contest, participants agree to be bound by the decisions of Station personnel. Persons who violate any rule, gain unfair advantage in participating in the Contest, or obtain winner status using fraudulent means will be disqualified. Unsportsmanlike, disruptive, annoying, harassing or threatening behavior is prohibited and may result in disqualification in the Station's sole and absolute discretion. The Station will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules or the Contest and the Station's decisions concerning such disputes shall be final. If the conduct or outcome of the Contest is affected by human error, any mechanical malfunctions or failures of any kind, intentional interference or any event beyond the control of the Station, the Station reserves the right to terminate this Contest, or make such other decisions regarding the administration or outcome as the Station deems appropriate. All decisions will be made by the Station are final. The Station may waive any of these rules in its sole discretion. 17. The Contest and these Official Rules are governed by and shall be construed in accordance with the laws of the State of Illinois, without regards to principles of conflicts of law. You irrevocably agree to personal jurisdiction by the federal and state courts located in the County of Winnebago in the State of Illinois and waive any jurisdictional, venue or inconvenient forum objections to such courts. Further, in any such dispute, under no circumstances will you be permitted to obtain awards for, and you hereby irrevocably waive all rights to claim punitive, incidental, or consequential damages, or any other damages, including attorneys' fees, other than your actual out-of-pocket expenses (i.e., costs associated with participating in the Contest), and you further irrevocably waive all rights to have damages multiplied or increased. YOU AGREE THAT ANY CAUSE OF ACTION ARISING OUT OF OR RELATED TO YOUR ENTRIES OR OTHERWISE RELATED TO THE CONTEST MUST COMMENCE WITHIN ONE (1) YEAR AFTER THE CAUSE OF ACTION OCCURS, OTHERWISE, SUCH CAUSE OF ACTION SHALL BE PERMANENTLY BARRED.
